




HERE TO SERVE - ANGELINA

Ostakan 40, 4040	Formed estrance Liplane Medicalia was have in Grassiv, Daland, Champy


- October 12, 1840 Famed actress Helena Modjeska was born in Cracow, Poland. She moved to Orange County in 1876 and became our most famous early resident.
