SATURDAY HOURS PLANNED FOR AUGUST 18

The Clerk-Recorder Department will once again open its doors to the public on August 18, 2018 for its once-a-month Saturday hours. The department's branch offices in Fullerton and Laguna Hills as well as the Old County Courthouse in Santa Ana, will be open from 10 am to 3 pm. Customers will be able to obtain marriage licenses, have marriage ceremonies performed, submit passport applications, purchase passport photos and obtain vital and official records.

CLERK-RECORDER CELEBRATES FIVE-YEAR ANNIVERSARY OF SPECIAL SATURDAY OPENINGS TO THE PUBLIC

This past July 21, Clerk-Recorder Hugh Nguyen celebrated the five-year anniversary in which he has opened his offices to the public one Saturday per month. The program was implemented shortly after Clerk-Recorder Nguyen took his position in the year 2013. Since the implementation of the special Saturday hours, demand has continued to increase and the openings have become very popular with wedding parties and other customers.

Since taking office, Clerk-Recorder Hugh Nguyen has been committed to making it easier for constituents to access his department's services. The special Saturday hours, which are from 10 a.m. to 3 p.m., make it easier for working families, busy individuals and students to obtain services without having to miss work or school.

As of this past July Saturday opening, the department has issued 9,116 marriage licenses, performed 6,244 marriage ceremonies, and issued 3,565 vital records during the department's special Saturday hours. The department has also accepted 2,124 passport applications. Approximately, 36,000 customers were served and over 60,000 guests visited our offices during these special hours.

"I am just amazed at all the work we have done for the residents of our County during these Saturday openings," Clerk-Recorder Hugh Nguyen said. "I love to watch the crowds gather, on special Saturdays, waiting to obtain the services that they need without having to miss work or school. I would also like to thank my amazing staff for making these five years of service to the public possible."

To make the day even more memorable, the Herrera sisters, Jeanne and America, decided to get married on the same day, at same place and at the same time. Their ceremony was performed at the Old County Courthouse. Congratulations to the sisters and their spouses!

BUD HURLBUT

Master of Amusement

Wendell "Bud" Hurlbut (1918-2011) of Buena Park, was an entrepreneur, designer, and unsung giant of the amusement park industry. He introduced ideas that became industry standards, he restored vintage attractions, he created Riverside's Castle Park, and he crafted beautiful miniature trains. Only Hurlbut's modesty prevented him from being as famous as Disney's Imagineers. Locally, he is best remembered for the many rides he designed, built and operated for Knott's Berry Farm, including the Calico Mine Ride and the Timber Mountain Log Ride. Such attractions were foundational to the engineering, business operation, and artistic design of the modern theme park.

JULY IN O.C. HISTORY

- July 1, 1810** The Spanish Governor of Alta California granted the 62,516 acre Rancho Santiago de Santa Ana to Jose Antonio Yorba and to Yorba's nephew, Juan Pablo Peralta. Today, numerous communities occupy this rancho's land, including Santa Ana, Orange, Tustin, Costa Mesa, Villa Park, Anaheim Hills, El Modena and part of Irvine.
- July 6, 1936** Hundreds of striking agricultural workers march through Orange County's citrus groves under the aegis of the Federation of Agricultural Workers Union of America. They demanded increased pay and other concessions, and savagely beat "scabs", grove owners, and guards.
- July 11, 1969** John Wayne and his son, John Ethan, became the first to ride Knott's Berry Farm's new Timber Mountain Log Ride on its opening day. (A new exhibit about Log Ride inventor and "Dean of Amusement Parks" Bud Hurlbut is currently on display at the Orange County Archives in the Old Courthouse.)
- July 13, 2007** Members of the media were given preview rides in the new "Great Park" promotional balloon at the formal Marine Corps Air Station El Toro.
- July 30, 1951** The contract was awarded for the construction of the 75-bed Hoag Memorial Hospital in Newport Beach.
